## Tennessee Doctor Pleads Guilty To Maintaining An Illegal Drug Premises

On September 13, 2021, Dr. David Newman, 61, of Maryville, Tenn. entered a guilty plea to maintaining his pain clinic as an illegal drug premises in the Eastern District of Tennessee.

Sentencing has been set for February 9, 2022, at 3:00 pm, before the Honorable

Thomas Varlan, U.S. District Judge, in the United States District Court at Knoxville. Newman faces a maximum sentence of 20 years in prison.

According to court documents, Newman owned, operated, and was Medical Director of Tennessee Valley Pain Specialists

(TVPS), a non-insurance, cash-equivalent pain clinic. Newman owned this clinic with Dr. Steven Mynatt. Newman continued to operate and serve as Medical Director of TVPS, despite knowing that Mynatt was prescribing opioids to patients outside profes-



David Fisher, 36, Burnette Station Road Seymour, was charged with Aggravated Assault, and Vandalism.

Deputy Swinney LCSO, was dispatched to Town Creek Rd. E. in reference to a domestic assault that had just occurred. Deputy arrived on scene and was met by the victim. Before speaking with victim, Deputy did observe glass and coins scattered in the driveway, and a vehicle with a busted out drivers side window and windshield. Deputy asked victim to explain what had happened and she stated that she and her ex-fiancé David Fisher had an argument and David smashed out the win-

dows and came at her with what she believed to be a crowbar and then left heading towards Friendsville, TN. Deputy Mark Tinnel, attempted to initiate traffic stop and stopped the Dollar General in Friendsville, TN. Deputy had victim provide a written statement and explain in detail what happened. According to victim, around 0845 she had asked David how much longer he would be at the residence since he was in the process of moving out. They discussed monies owed on an engagement ring and David then started to load his truck and trailer with his belongings. They argued over the TV and Play Station 5 while in the driveway. She said

that he went into the house, damaging the door frame, flipped and broke the TV, came outside where victim had the coin jar, David grabbed what she believed to be a crowbar and began smashing the windows on her vehicles, she stated that she was placed in fear of bodily injury when David grabbed the crowbar. She attempted to record the incident but David pulled the phone from her hands and threw it into her vehicle. Then he left the area and she called 911. Deputy advised victim on her options of how to obtain a Order of Protection as well and explained the bond conditions David would be on if he was able to bond out. Deputy also provided her with documentation on how to seek help from Domestic Violence Situations. David was placed under arrest and transported to the Loudon County Jail by Cpl. Brian

Smith and his vehicle and trailer was towed by Money-makers Wrecker. Checking with the respective dealerships, it was determined the following replacement costs Infinity G37S-front windshield (979.45), driver side door assembly (1360.55), and driver side window (719.92); for the Nissan Cube Driver side rear passenger window (243.56).

sional practice and for no legitimate medical purpose. Newman and Mynatt were charged with drug-related offenses as part of the April 2019 Appalachian Regional Prescription Opioid Strike Force Surge; Mynatt entered a guilty plea related to his distribution of controlled substances at TVPS in February 2020.

Assistant Attorney General Kenneth A. Polite Jr. of the Justice Department's Criminal Division; Acting U.S. Attorney Francis M. Hamilton III for the Eastern District of Tennessee; Special Agent in Charge J. Todd Scott of the Drug Enforcement Administration (DEA); Special Agent in Charge Joseph Carrico of the FBI's Knoxville Field Office; Special Agent in Charge Derrick Jackson of the Department of Health and Human Services, Office of the In-

spector General (HHS-OIG); and Special Agent in Charge Andy Corbitt of the Tennessee Bureau of Investigation (TBI) made the announcement.

The investigation was conducted by the DEA, FBI, HHS-OIG, and TBI.

Trial Attorney Louis Manzo, Assistant Chief Jillian Willis of the Justice Department's Fraud Section, and Assistant U.S. Attorney Anne-Marie Svolto of the Eastern District of Tennessee are prosecuting the case.

The Fraud Section leads the Appalachian Regional Prescription Opioid (ARPO) Strike Force. Since its inception in October 2018, the ARPO Strike Force, which operates in 10 districts, has charged more than 85 defendants who are collectively responsible for distributing more than 65 million pills.


ey' inside a paper bag. Ms. Smart claimed ownership of the meth, paraphernalia and gun.
